➤ **Section 18 Handicaps - "Novice" and "New" players**
Amendment to existing Rule 18c

Such "Novice" and "New" players will have their handicaps adjusted at every monthly meeting after the player has played two games and until they have played 6 games in any number of seasons.

➤ **Section 18 Handicaps - “Re-handicapping formula
Amendment to existing Rule 18e**

This change is to amend the existing text

Adjustments are 1.0 point per win/loss difference, for example

If a player has won 9 and lost 5 , a difference of +4 then their handicap is reduced by 4,

If a player has lost 9 and won 5 , a difference of -4 then their handicap is increased by 4,

With

Adjustments are 0.5 point per win/loss difference, for example

If a player has won 9 and lost 5 , a difference of +4 then their handicap is reduced by 2,

If a player has lost 9 and won 5 , a difference of -4 then their handicap is increased by 2,

➤ **New Rule - Attending League Meetings**

Submitted by League Committee

All teams will pay an initial £15.00 bond, (teams within the League as of last season, will have this bond paid for by the League) to ensure that a representative from the team attends the following meetings : e.g. Formation Meeting ; September Meeting and the Annual General Meeting.

Should a representative fail to attend all of these meetings the bond is paid as a fine, and a new bond will have to be paid as part of next seasons registration Fee, i.e. £60.00 + £15.00. If a representative attends all these meetings the bond is carried over into the following season.

This will enable the removal of fines for missing any League meeting.

10. Any Other Business (Open discussion)

- **Introduction of a new Competition – Seniors Cup**

The old 3rd Division Annual Trophy to be reused for this competition.

This handicapped competition would be open to team players over the age of 60. The Competition will be played similar to the format for the Individual Handicap Competition, will ALL matches being the best of 3 frames.

Entrance fee is £4.00.

Prize Monies would be dependent upon entries

- **Amendment to the format of both the Individual Handicap and Merit Competitions**

The match will be the Best of 3 frames, with the Semi-Final and Final being the best of 5 frames.
